## Public Services Memo

RE: Hofma Park and Preserve Trail Rehabilitation and ADA Nature Trail Construction

---

One of the projects slated for completion this year was creation of a barrier free access trail loop in Hofma Park/Preserve and additional trail way maintenance. There was \$25,000 budgeted for the completion of this project. This project is also identified in the Township's last solo Parks and Recreation Master plan.

This spring, staff completed a comprehensive review of all the trail segments in both Hofma Park and Preserve. Through this evaluation it was determined that there are approximately 6525 feet of trail in need of repair. The trails show signs of wear due to the amount of use and, over time, tree roots have begun to show and ruts have been created in portions of the path. Although in the vast majority of cases the wear is not severe, it was felt that now is the time to complete rehabilitation of the worn segments before it becomes any worse and our natural resources become damaged.

In addition, there is 1400 feet of existing trail that is planned to be turned into an ADA accessible trail. A site overview map is attached for your reference.

A 138-page *Request for Bids* has been drafted for this project and is available for review. Due to the extensive amount of repair being recommended, the bid document reflects the trail repair as the primary purpose and the construction of the ADA pathway as an alternate.


The bid request will be sent to area contractors as well as listing on Builders Exchange and Dodge Report websites to gain more interest. Bids will be received until 10:00 a.m., Tuesday, May 2, 2017 at which time they will be opened. The results will be forwarded to the elected officials for action at the May 8<sup>th</sup> Board meeting.

*As required by the Administrative Policy and Procedure Manual, any purchase for goods or services exceeding an estimated contract cost of \$15,000 shall require the solicitation of sealed bids and the bid specifications shall be approved by the Township Board.*

RE: Second Reading – Code Enforcement Amendment Ordinance

### BACKGROUND

While performing due diligence research on Township Ordinances staff determined the Code/Ordinance Enforcement Ordinance would be improved by adding the Code Enforcement Officer to the definition of an “Authorized Township Official.”

The Board had a first reading on the proposed amendment on March 27<sup>th</sup>.

### REASONING

Although the current language of the ordinance is sufficient, by adding the Code Enforcement Officer to the definition the Township strengthens this ordinance by specifically delegating this duty to the police officers and the Code Enforcement Officer.

**CODE/ORDINANCE ENFORCEMENT AMENDMENT ORDINANCE  
GRAND HAVEN CHARTER TOWNSHIP**

AN ORDINANCE TO AMEND SECTION 2.2 OF THE CHARTER TOWNSHIP OF GRAND HAVEN CODE/ORDINANCE ENFORCEMENT ORDINANCE TO AMEND THE AUTHORIZED TOWNSHIP OFFICIAL DEFINITION.

GRAND HAVEN CHARTER TOWNSHIP, COUNTY OF OTTAWA, AND STATE OF MICHIGAN, ORDAINS:

Section 1. Definitions. Section 2.2 of the Code/Ordinance Enforcement Ordinance shall be restated in its entirety as follows.

2. “Authorized Township Official” means a police officer, a Code Enforcement Officer, or other personnel of the Charter Township of Grand Haven authorized by this Ordinance or any Ordinance to issue municipal civil infraction citations or municipal civil infraction violation notices.

Section 2. Effective Date. This Ordinance was approved and adopted by the Township Board of the Charter Township of Grand Haven, Ottawa County, Michigan, on \_\_\_\_\_, after introduction and a first reading on March 27, 2017, and after posting and publication following such first reading as required by Michigan Act 359 of 1947, as amended. This Ordinance shall be effective on \_\_\_\_\_, which date is 30 days after adoption of the Ordinance.
